For Targeted Freight and Exhibitor Set Up Only

<b>Receive Direct Freight</b> There will be an additional 50% drayage surcharge for not meeting the target date and time. Below is the deadline that your booth display (this does not include product) must be checked in at the marshalling yard. Strict adherence to this schedule will expedite the installation of your exhibit.	<b>Exhibitor Set Up May Begin</b> Below is when you and/or your EAC may begin to install your booth. If you have rented a booth package from GES, the booth will be constructed and available for merchandising on Sunday 2/12/12 at 8am unless otherwise requested. All crates must be emptied and labeled for removal by GES no later than 10:00pm on Saturday, 2/11/12.

Lobby and meeting room booths/exhibitors move-in date, Friday, 2/10/12, 1pm.

Set-up for all exhibitors may begin as soon as freight is received in your booth.

Each in-line exhibitor must provide a 9" electrical access behind booth. Each peninsula booth must provide an 18" electrical access behind booth. Advance freight sent to the GES warehouse will be delivered to the booth no later than the published target date/time. Refer to "Exhibitor Set-Up May Begin" to schedule booth installation labor.

## Marshalling Yard Hours:

Marshalling yard hours of operation are provided for your convenience. Drivers must check-in at the marshalling yard no later than 2 pm to guarantee same day unloading.

Please note, if your shipment does not arrive by your target time, you may be charged a 50% surcharge on your drayage. A 50% surcharge also applies if your shipment is not picked up by your target time on the move-out.
